Description of content: The Federal Government completed a detailed safety assessment of a food additive submission seeking approval for the use of ground limestone as a colouring agent in hard and soft candies and in edible inks for writing on certain confectionery. The results of Health Canada's evaluation of available scientific data support the safety of ground limestone for use as a colouring agent in such unstandardized confectionery. Therefore, Health Canada intends to modify the *List of Permitted Colouring Agents* (https://www.canada.ca/en/health-canada/services/food-nutrition/food-safety/food-additives/lists-permitted/3-colouring-agents.html) as described in the information document referenced below.
