Established Maximum Residue Limits: Fluazifop-butyl

The proposed maximum residue limit (PMRL) document for fluazifop-butyl notified in G/SPS/N/CAN/1229 (dated 10 December 2018) was adopted 25 February 2019. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

5.0 3.0	Leaf lettuce Head lettuce
1.5 0.5	Green onions (crop subgroup 3-07B) Bulb onions (crop subgroup 3-07A, except dry bulb onions) ²
