Addendum

The following communication, received on 28 February 2019, is being circulated at the request of the Delegation of Canada.

Established Maximum Residue Limit: Flumioxazin

The proposed maximum residue limit (PMRL) document for flumioxazin notified in G/SPS/N/CAN/1230 (dated 10 December 2018) was adopted 25 February 2019. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.5 Sunflowers (crop subgroup 20B)

¹ ppm = parts per million

MRLs are established for each commodity included in the listed crop groupings in accordance with the *Residue Chemistry Crop Groups* webpage (<https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html>) in the Pesticides and Pest Management section of the Canada.ca website.
