#### Addendum

The following communication, received on 6 June 2019, is being circulated at the request of the Delegation of <u>Canada</u>.

### Established Maximum Residue Limit: Cyantraniliprole

The proposed maximum residue limit (PMRL) document for cyantraniliprole notified in G/SPS/N/CAN/1241 (dated 8 March 2019) was adopted 4 June 2019. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

### MRL (ppm)<sup>1</sup> Raw Agricultural Commodity (RAC) and/or Processed Commodity

4.0 Caneberries (crop subgroup 13-07A)

1.5 Strawberries
