The following communication, received on 5 December 2019, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Cyclaniliprole

The proposed maximum residue limit (PMRL) document for cyclaniliprole notified in G/SPS/N/CAN/1272 (dated 9 September 2019) was adopted 27 November 2019. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity
50 Tea (dried leaves)
