## NOTIFICATION

### *Addendum*

The following communication, received on 16 November 2020, is being circulated at the request of the Delegation of Canada.

---

#### Established Maximum Residue Limit: Flupyradifurone

The proposed maximum residue limit (PMRL) document for flupyradifurone notified in G/SPS/N/CAN/1329 (dated 19 August 2020) was adopted 9 November 2020. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

<u>MRL (ppm)<sup>1</sup></u>	<u>Raw Agricultural Commodity (RAC) and/or Processed Commodity</u>
0.1	Fat of cattle, goats, horses and sheep <sup>2</sup>
0.07	Milk <sup>2</sup>
0.03	Rapeseeds (crop subgroup 20A) (revised)

<sup>1</sup>ppm = parts per million

<sup>2</sup>The MRLs replace the currently established MRLs of 0.06 ppm.

An MRL is established for each commodity included in the listed crop groupings in accordance with the *Residue Chemistry Crop Groups* webpage (<https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html>) in the Pesticides and Pest Management section of the Canada.ca website.

The database allows users to search for pesticides or for food commodities.
