Addendum

The following communication, received on 16 March 2021, is being circulated at the request of the Delegation of Canada.

Established Maximum Residue Limit: Ethalfluralin

The proposed maximum residue limit (PMRL) document for ethalfluralin notified in G/SPS/N/CAN/1361 (dated 15 December 2020) was adopted 8 March 2021. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.05 Gold of pleasure seeds

¹ ppm = parts per million
