Addendum

The following communication, received on 24 June 2021, is being circulated at the request of the Delegation of Canada.

Established Maximum Residue Limit: Dichlobenil

The proposed maximum residue limit (PMRL) document for dichlobenil notified in G/SPS/N/CAN/1380 (dated 31 March 2021) was adopted 21 June 2021. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.5 Currants

¹ ppm = parts per million

MRLs established in Canada may be found using Health Canada's *Maximum Residue Limit Database* (<http://pr-rp.hc-sc.gc.ca/mrl-lrm/index-eng.php>) on the *Maximum Residue Limits for Pesticides* webpage (<https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/maximum-residue-limits-pesticides.html>). The database allows users to search for pesticides or for food commodities.
