## NOTIFICATION

### *Addendum*

The following communication, received on 4 August 2022, is being circulated at the request of the Delegation of Canada.

#### Established Maximum Residue Limit: Topramezone

The proposed maximum residue limit (PMRL) document for topramezone notified in G/SPS/N/CAN/1435 (dated 2 May 2022) was adopted 27 July 2022. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm) <sup>1</sup>	<u>Raw Agricultural Commodity (RAC) and/or Processed Commodity</u>
0.05	Fat and meat by-products of poultry <sup>2</sup>
0.01	Rapeseeds <sup>3</sup> (crop subgroup 20A) (revised); eggs and meat of poultry <sup>2</sup>

<sup>1</sup> ppm = parts per million

<sup>2</sup> From poultry consumption of feed treated with topramezone.

<sup>3</sup> Canola is a variety of rapeseed.
