The following communication, received on 5 May 2014, is being circulated at the request of the Delegation of Canada.

Notice of Modification - Lists of Permitted Food Additives

The proposed modifications notified in G/SPS/N/CAN/736 were made available for comment until 20 December 2013 through the "*Consultation Document on Health Canada's Proposal to Enable the Use of Saccharin, Calcium Saccharin, Potassium Saccharin and Sodium Saccharin as Sweeteners in Various Unstandardized Foods*".

No safety concerns were raised through Health Canada's scientific assessment, or through the comments received during the corresponding consultation. Therefore, the Department has enabled the use of saccharin as described in the information document by updating the *List of Permitted Sweeteners*, effective 25 April 2014.

The purpose of this communication is to publically announce the Department's decision in this regard and to provide the appropriate contact information for any inquiries or for those wishing to submit any new scientific information relevant to the safety of this food additive.
