# Established Maximum Residue Limits: Sethoxydim

The proposed maximum residue limit (PMRL) document for sethoxydim notified in G/SPS/N/CAN/742 (dated 18 October 2013) was adopted 7 January 2014. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm)	Raw Agricultural Commodity (RAC) and/or Processed Commodity
25	Rapeseeds (canola)
4.0	Bushberry Subgroup (Crop Subgroup 13-07B)
2.5	Borage Seeds
