## NOTIFICATION

### Addendum

The following communication, received on 14 January 2014, is being circulated at the request of the Delegation of Canada.

#### Established Maximum Residue Limit: MCPA

The proposed maximum residue limit (PMRL) document for MCPA notified in G/SPS/N/CAN/743 (dated 18 October 2013) was adopted 7 January 2014. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

<u>MRL (ppm)</u>	<u>Raw Agricultural Commodity (RAC) and/or Processed Commodity</u>
0.1	Dry field peas; edible-podded peas; succulent shelled peas
0.05	Eggs; fat, meat and meat by-products of cattle, goats, hogs, horses, poultry and sheep
0.04	Wheat bran
0.03	Barley; oats; rye; wheat
0.015	Sweet corn kernels plus cob with husks removed
0.01	Field corn; flaxseeds; milk

ppm = parts per million
