The following communication, received on 14 January 2014, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: MCPA

The proposed maximum residue limit (PMRL) document for MCPA notified in G/SPS/N/CAN/743 (dated 18 October 2013) was adopted 7 January 2014. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm)	Raw Agricultural Commodity (RAC) and/or Processed Commodity							
0.1 0.05	Dry field peas; edible-podded peas; succulent shelled peas Eggs; fat, meat and meat by-products of cattle, goats, hogs, horses, poultry and sheep							
0.04 0.03 0.015 0.01	Wheat bran Barley; oats; rye; wheat Sweet corn kernels plus cob with husks removed Field corn; flaxseeds; milk
