#### Addendum

The following communication, received on 6 February 2014, is being circulated at the request of the Delegation of <u>Canada</u>.

## Established Maximum Residue Limits: Oxyfluorfen

The proposed maximum residue limit (PMRL) document for oxyfluorfen notified in G/SPS/N/CAN/754 (dated 11 November 2013) was adopted 1 February 2014. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm) Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.05 Head and stem brassica subgroup (Crop Subgroup 5A)

ppm = parts per million
