Established Maximum Residue Limits: Boscalid

The proposed maximum residue limit (PMRL) document for boscalid notified in G/SPS/N/CAN/756 (dated 11 November 2013) was adopted 1 February 2014. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

1.6 3.5	Sunflower Subgroup (Crop Subgroup 20B) Mustard seeds (condiment type)
