Raw Agricultural Commodity (RAC) and/or Processed Commodity MRL (ppm) Tree Nuts (Crop Group 14-11) 0.1 ppm = parts per million MRLs are proposed for each commodity included in the listed crop groupings in accordance with the Residue Chemistry Crop Groups webpage http://www.hcsc.gc.ca/cps-spc/pest/part/protect-proteger/food-nourriture/rccg-gcpcr-eng.php in the Pesticides and Pest Management section of Health Canada's website. 7.
