The following communication, received on 25 March 2014, is being circulated at the request of the Delegation of Canada.

Established Maximum Residue Limits: Myclobutanil

The proposed maximum residue limit (PMRL) document for myclobutanil notified in G/SPS/N/CAN/783 (dated 19 December 2013) was adopted 15 March 2014. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

<u>MRL (ppm)</u>	<u>Raw Agricultural Commodity (RAC) and/or Processed Commodity</u>
2.0	Caneberries (Crop Subgroup 13-07A)
1.5	Bushberries (Crop Subgroup 13-07B), except currants
0.6	Pears
0.3	West Indian gherkins, muskmelons (other than those listed)

ppm = parts per million
