Description of content: Health Canada's Food Directorate completed a detailed safety assessment of asparaginase obtained from <i>Aspergillus niger</i> AGN7-41 as a food enzyme in bread, flour, whole wheat flour, and unstandardized foods. Asparaginase, when obtained from another strain of <i>Aspergillus niger</i> (<i>A. niger</i> ASP72), is already permitted for use in Canada as a food enzyme in bread, flour, whole wheat flour and unstandardized foods. As no safety concerns were raised through this assessment, the Department has enabled the food additive use described in the information document by updating the <i>List of Permitted Food Enzymes</i> , effective 21 January 2014. The purpose of this communication is to publically announce the Department's decision in this regard and to provide the appropriate contact information for any inquiries or for those wishing to submit any new scientific information relevant to the safety of this food additive. Health Canada's Food Directorate is committed to reviewing any new scientific information on the safety in use of any food additive, including asparaginase obtained from <i>Aspergillus niger</i> AGN7-41. Anyone wishing to submit new scientific information on the use of this additive or to submit any inquiries may do so in writing, by regular mail or electronically.
