#### Addendum

The following communication, received on 4 September 2014, is being circulated at the request of the Delegation of <u>Canada</u>.

Policy on the Control of E. coli O157: H7/NM Contamination in Raw Beef Products

The proposal notified in G/SPS/N/CAN/805 (dated 31 March 2014) was adopted with amendments on 21 August 2014. The Canadian Food Inspection Agency (CFIA) is implementing a policy to allow for a three month transition period of these final amendments before enforcement.

CFIA has revised its Policy on the Control of *E. coli* O157:H7/NM Contamination in Raw Beef Products and finalized its labelling requirements for mechanically tenderized beef:

- Changes in the manner of identifying "mechanically tenderized";
- Safe cooking instructions revised to "Cook to a minimum internal temperature of  $63^{\circ}$ C (145°F)"; and
- In the case of steaks, an additional safe cooking instruction indicating "Turn steak over at least twice during cooking" to help achieve a consistent temperature throughout.
