Addendum

The following communication, received on 17 September 2014, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limits: Cyprodinil

The proposed maximum residue limit (PMRL) document for cyprodinil notified in G/SPS/N/CAN/825 (dated 13 June 2014) was adopted 1 September 2014. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm) Raw Agricultural Commodity (RAC) and/or Processed Commodity

1.7 Crop Group 11-09 (Pome fruits)^a

0.02 Fat, meat and meat byproducts of cattle, goats, hogs, horses and sheep; milk

ppm = parts per million

^a this action revises the established Canadian MRL of 0.1 ppm for Pome fruit to accommodate a reduction in the preharvest interval and adds MRLs for the remaining commodities in the revised Crop Group 11-09.

MRLs are proposed for each commodity included in the listed crop groupings in accordance with the *Residue Chemistry Crop Groups* webpage (http://www.hc-sc.gc.ca/cps-spc/pest/part/protect-proteger/food-nourriture/rccg-gcpcr-eng.php) in the Pesticides and Pest Management section of Health Canada's website.

MRLs established in Canada may be found using Health Canada's *Maximum Residue Limit Database* (http://pr-rp.hc-sc.gc.ca/mrl-lrm/index-eng.php) on the *Maximum Residue Limits for Pesticides* webpage (http://www.hc-sc.gc.ca/cps-spc/pest/part/protect-proteger/food-nourriture/mrl-lmr-eng.php).
