Description of content: The objective of the notified document PMRL2014-43 is to consult on the listed domestic maximum residue limit (MRL) for pyrooxasulfone and the metabolite M-28 that has been proposed by the Health Canada's Pest Management Regulatory Agency (PMRA). <u>MRL (ppm) Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 0.06 Dry soybeans ppm = parts per million MRLs are proposed for each commodity included in the listed crop groupings in accordance with the <i>Residue Chemistry Crop Groups</i> webpage (http://www.hc-sc.gc.ca/cps-spc/pest/part/protect-proteger/food-nourriture/rccg-gcpcr-eng.php) in the Pesticides and Pest Management section of Health Canada's website.
