Established Maximum Residue Limit: Lambda-cyhalothrin

The proposed maximum residue limit (PMRL) document for Lambda-cyhalothrin notified in G/SPS/N/CAN/872 (dated 24 September 2014) was adopted 6 December 2014. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm) Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.05 Tree nuts (Crop Group 14-11)^a ppm = parts per million

^a Currently, there is an MRL of 0.05 ppm established in/on Tree nuts (Crop Group 14) and pistachios.

MRLs are established for each commodity included in the listed crop groupings in accordance with the Residue Chemistry Crop Groups webpage (http://www.hc-sc.gc.ca/cps-spc/pest/part/protect-proteger/food-nourriture/rccg-gcpcr-eng.php) in the Pesticides and Pest Management section of Health Canada's website.
