The proposed maximum residue limit (PMRL) document for flonicamid notified in G/SPS/N/CAN/907 (dated 22 December 2014) was adopted 11 March 2015. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:
