The following communication, received on 2 June 2015, is being circulated at the request of the Delegation of Canada.

Established Maximum Residue Limit: Picoxystrobin

The proposed maximum residue limit (PMRL) document for picoxystrobin notified in G/SPS/N/CAN/918 (dated 4 March 2015) was adopted 28 May 2015. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm) Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.08 Mustard seeds (condiment type)

ppm = parts per million

MRLs established in Canada may be found using Health Canada's *Maximum Residue Limit Database* (<http://pr-rp.hc-sc.gc.ca/mrl-lrm/index-eng.php>) on the *Maximum Residue Limits for Pesticides* webpage (<http://www.hc-sc.gc.ca/cps-spc/pest/part/protect-proteger/food-nourriture/mrl-lmr-eng.php>).
