Description of content: The objective of the notified document PMRL2015-11 is to consult on the listed domestic maximum residue limits (MRLs) for dimethenamid that have been proposed by the Health Canada's Pest Management Regulatory Agency (PMRA). <u>MRL (ppm)</u> <u>Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 0.01 Small fruit vine climbing, except fuzzy kiwifruit subgroup (Crop Subgroup 13-07F) ppm = parts per million MRLs are proposed for each commodity included in the listed crop groupings in accordance with the <i>Residue Chemistry Crop Groups</i> webpage (http://www.hc-sc.gc.ca/cps-spc/pest/part/protect-proteger/food-nourriture/rccg-gcpcr-eng.php) in the Pesticides and Pest Management section of Health Canada's website.
