The following communication, received on 23 September 2015, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Spiroxamine

The proposed maximum residue limit (PMRL) document for spiroxamine notified in G/SPS/N/CAN/931 (dated 18 May 2015) was adopted 18 September 2015. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm) Raw Agricultural Commodity (RAC) and/or Processed Commodity

4.0 Raisins 3.0 Bananas

2.0 Banana 2.0 Grapes

ppm = parts per million
