Addendum

The following communication, received on 23 September 2015, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Tembotrione

The proposed maximum residue limit (PMRL) document for tembotrione notified in G/SPS/N/CAN/939 (dated 26 June 2015) was adopted 21 September 2015. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm) Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.01¹ Sweet corn kernels plus cob with husks removed

ppm = parts per million

¹ The MRL of 0.01 ppm for residues of tembotrione only is proposed to replace the established MRL of 0.04 pm for the combined residues of tembotrione and the metabolite 2-[2-chloro-4-(methylsulfonyl)-3-[2,2,2-trifluoroethoxy)methyl]benzoyl]-4,6-dihydroxycyclohexane-1,3-dione for sweet corn kernels plus cob with husks removed.
