### Established Maximum Residue Limit: Imazamethabenz-methyl

The proposed maximum residue limit (PMRL) document for imazamethabenz-methyl notified in G/SPS/N/CAN/958 (dated 18 September 2015) was adopted 14 December 2015. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm) Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.05 Borage seeds

ppm = parts per million
