The following communication, received on 17 December 2015, is being circulated at the request of the Delegation of <u>Canada</u>.

# Established Maximum Residue Limit: Rimsulfuron

The proposed maximum residue limit (PMRL) document for rimsulfuron notified in G/SPS/N/CAN/959 (dated 18 September 2015) was adopted 14 December 2015. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm) Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.01 Caneberry (Crop Subgroup 13-07A)

ppm = parts per million

MRLs are established for each commodity included in the listed crop groupings in accordance with the *Residue Chemistry Crop Groups* webpage (<a href="http://www.hc-sc.gc.ca/cps-spc/pest/part/protect-proteger/food-nourriture/rccg-gcpcr-eng.php">http://www.hc-sc.gc.ca/cps-spc/pest/part/protect-proteger/food-nourriture/rccg-gcpcr-eng.php</a>) in the Pesticides and Pest Management section of Health Canada's website.
