Addendum

The following communication, received on 30 December 2015, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Pyraclostrobin

The proposed maximum residue limit (PMRL) document for pyraclostrobin notified in G/SPS/N/CAN/962 (dated 19 October 2015) was adopted 24 December 2015. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm) Raw Agricultural Commodity (RAC) and/or Processed Commodity

40 Garden beet tops, radish tops

ppm = parts per million

MRLs established in Canada may be found using Health Canada's *Maximum Residue Limit Database* (<u>http://pr-rp.hc-sc.gc.ca/mrl-lrm/index-eng.php</u>) on the *Maximum Residue Limits for Pesticides* webpage (<u>http://www.hc-sc.gc.ca/cps-spc/pest/part/protect-proteger/food-nourriture/mrl-lmr-eng.php</u>). The database allows users to search for pesticides(s) or for food commodity(ies).
