## NOTIFICATION

### *Addendum*

The following communication, received on 10 February 2016, is being circulated at the request of the Delegation of Canada.

#### Established Maximum Residue Limit: Cyazofamid

The proposed maximum residue limit (PMRL) document for cyazofamid notified in G/SPS/N/CAN/978 (dated 11 November 2015) was adopted 8 February 2016. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

#### MRL (ppm)      Raw Agricultural Commodity (RAC) and/or Processed Commodity

12	Crop Subgroup 5B (Leafy <i>Brassica</i> Greens)
1.2 <sup>1</sup>	Crop Subgroup 5A (Head and Stem <i>Brassica</i> )

ppm = parts per million

<sup>1</sup> The MRLs of 1.2 ppm replace the currently established MRLs of 0.02 ppm for Crop Subgroup 5A (Head and Stem *Brassica*).

MRLs are established for each commodity included in the listed crop groupings in accordance with the *Residue Chemistry Crop Groups* webpage (<http://www.hc-sc.gc.ca/cps-spc/pest/part/protect-protoger/food-nourriture/rccg-gcpcr-eng.php>) in the Pesticides and Pest Management section of Health Canada's website.

MRLs established in Canada may be found using Health Canada's *Maximum Residue Limit Database* (<http://pr-rp.hc-sc.gc.ca/mrl-lrm/index-eng.php>) on the *Maximum Residue Limits for Pesticides* webpage (<http://www.hc-sc.gc.ca/cps-spc/pest/part/protect-protoger/food-nourriture/mrl-lmr-eng.php>). The database allows users to search for pesticides(s) or for food commodity(ies).
