## NOTIFICATION

### Addendum

The following communication, received on 2 April 2015, is being circulated at the request of the delegation of Chile.

Phytosanitary requirements governing the importation into Chile of seeds, of any origin, for fruit and vegetable crops and aromatic and medicinal plant species

The Republic of Chile hereby advises that, pursuant to Agriculture and Livestock Service Resolution No. 1274 of 2015, Resolution No. 7.386 of 2014 has been amended by the addition of a new Article, No. 14, which reads as follows: "Countries with seed stocks of the species *Citrullus lanatus* (= *C. vulgaris*), *Coriandrum sativum*, *Cucumis melo*, *Cucumis metuliferus*, *Cucumis sativus*, *Cucurbita ficifolia*, *Cucurbita foetidissima*, *Cucurbita maxima*, *Cucurbita moschata*, *Cucurbita pepo*, *Cucurbita pepo* var. *medullosa*, *Daucus carota*, *Lablab purpureus* (= *Dolichos lablab*), *Phaseolus coccineus* (= *P. multiflorus*), *Phaseolus lunatus*, *Phaseolus vulgaris*, *Pisum sativum*, *Vigna mungo* (= *Phaseolus mungo*), *Vigna radiata* var. *radiata* (= *Phaseolus aureus*) and *Vigna unguiculata* (= *Vigna sinensis*) that are unable to provide the additional declaration established for bacteria may, until 31 December 2015, provide the following additional declaration: "The consignment is from a nursery that was inspected during the active growth period and found to be free from (name of bacterium)".
