China has four kinds of edible salt with different limits of the content of sodium chloride according to the characteristics of products in this standard. The content of sodium chloride is not less than 97% in the refined salt, 95.5% in the rushed and washed salt, 90% in the solar salt, 70.00±10(wt)% in the low sodium salt, respectively.
