Nature of the urgent problem(s) and reasons for urgent action: On 23 June 2017, the ICA's inspection, monitoring and control services identified an outbreak of type O foot-and-mouth disease in the municipality of Tame in the department of Arauca. The Arauca branch office of the ICA subsequently imposed sanitary quarantine in that municipality and in the department of Arauca.
