Description of content: The text amends the title and the specifications for Cochineal, Carminic acid, Carmines (E 120) as a follow up to the recommendations made in the EFSA opinion re-evaluating safety of this food additive. Annex II to Regulation (EC) No 1333/2008 (Union list of food additives approved for use in foods and conditions of use) and the Annex to Regulation (EU) No 231/2012 (specifications for food additives) are amended accordingly.

If no, describe, whenever possible, how and why it deviates from the international standard: The proposed regulation further aligns the specifications in certain aspects with the JECFA specifications (e.g. introducing the purity criteria and aligning with the limits for total ash, protein, matter insoluble in dilute ammonia and microbiological criteria) on the other hand it deviates as regards the limits for toxic elements (arsenic, lead, mercury and cadmium), amendment of the title of the food additive and inclusion of 4-aminocarminic acid in the specifications as a follow up to the recommendations made in the scientific opinion of EFSA.
