Description of content: These notified annexes to the draft Regulation set proposed maximum residue levels (MRLs) for bone oil, carbon monoxide, cyprodinil, dodemorh, iprodione, metalaxyl, metalaxyl-M, metaldehyde, metazachlor, paraffin oil (CAS 64742-54-7), petroleum oils (CAS 92062-35-6) and propargite. MRLs for these substances in certain commodities are changed: either increased or lowered. Lower MRLs are set after updating the limit of determinations and/or deleting old uses which are not authorised any more in the European Union or for which a human health concern may not be excluded.
