[] Yes [X] No If no, describe, whenever possible, how and why it deviates from the international standard: Draft MRLs for animal products, which are different from the Codex MRLs, are based on the results of residue trials, in reference to the US MRLs. The Japan's residue definition is sum of Spirotetramat and metabolite M1 [cis-3-(2,5dimethylphenyl)-4-hydroxy-8-methoxy-1-azaspiro[4.5]dec-3-en-2-one], expressed as Spirotetramat, which is the same as the US residue definition. However, Codex residue definition is metabolite M1 only. 9. Other relevant documents and language(s) in which these are available: Food Sanitation Act (available in English). When adopted, these MRLs are to be published in Kampo (Official Government Gazette) (available in Japanese). 10.
