Description of content: The proposed amendments seek to integrate processed livestock products with processed foods in order to clarify the overlapping regulations that impose a double burden of licensing and the necessary follow-up according to each regulation. For example, pork cutlets with less than 50 percentage of meat content are currently regulated by the Food Sanitation Act, instead of the Livestock Products Sanitary Control Act.
