- **5. Title of the notified document:** Decree of the Director General No. 388 of 12 December 2016 of the National Food Safety Agency "On preventive measures regarding the avian influenza". **Language(s):** Romanian. **Number of pages:** 2
- **Description of content:** The mentioned document relates to stepping up measures to prevent the introduction of avian influenza H5N8 disease in the territory of the Republic of Moldova. It introduces a temporary ban on the import and transit of live poultry, hatching eggs, eggs and egg products for consumption, day-old chicks, food for birds, feed additives for birds, feathers, meat and bone meal, poultry, poultry meat products from the regions of the countries mentioned in the point 4. The measures are taken on a temporary basis, id est until the stabilization of the epizootic situation in the mentioned regions.

Nature of the urgent problem(s) and reason for urgent action:** The scope of the mentioned Order is to ensure food safety, and protect animal health and humans against highly pathogenic avian influenza H5N8 disease, through imposing a temporary ban on the imported and transited products mentioned above.
