The following communication, received on 18 December 2014, is being circulated at the request of the delegation of <u>Mexico</u>.

Decision establishing measures to streamline administrative procedures governing the importation of new sawn wood originating in the United States of America or Canada, for the purposes of compliance with Mexican Official Standard NOM-016-SEMARNAT-2003 (Sanitary regulations on the importation of new sawn wood)

On 16 December 2014, the Ministry of the Environment and Natural Resources published in the Official Journal (*Diario Oficial de la Federación*) (http://www.dof.gob.mx) the Decision establishing measures to streamline administrative procedures governing the importation of new sawn wood originating in the United States of America or Canada, for the purposes of compliance with Mexican Official Standard NOM-016-SEMARNAT-2003 (Sanitary regulations on the importation of new sawn wood).

This Decision will enter into force 30 calendar days as of the date of its publication in the Official Journal.

This Decision is a measure to streamline administrative procedures, which provides for the endorsement, subject to prior examination, of the kiln-dried and phytosanitary treatment certificates issued by enterprises accredited by the official plant protection agencies of the United States of America, Canada or any other country whose legislation establishes similar procedures, as long as these are consistent with the provisions of the International Plant Protection Convention, for the purposes of certification by the Federal Environmental Protection Agency of compliance with specification 4.2.1(B) of Mexican Official Standard NOM-16-2013.
