Addendum

The following communication, received on 21 August 2015, is being circulated at the request of the delegation of <u>Mexico</u>.

Amendment to Mexican Official Standard NOM-068-FITO-2000: "Establishing phytosanitary measures to combat and prevent the spread of Moko disease in bananas", the title of which is now: Mexican Official Standard NOM-068-SAG/FITO-2015: "Establishing phytosanitary measures to combat and prevent the spread of Moko disease in bananas"

On 21 April 2000, the Ministry of Agriculture, Livestock, Rural Development, Fisheries and Food published Mexican Official Standard NOM-068-FITO-2000: "Establishing phytosanitary measures to combat and prevent the spread of Moko disease in bananas" in the Official Journal (*Diario Oficial de la Federación*) (http://www.dof.gob.mx).

The notified amendment to Mexican Official Standard NOM-068-FITO-2000: "Establishing phytosanitary measures to combat and prevent the spread of Moko disease in bananas" will enter into force 60 calendar days after its publication in the Official Journal, and Mexican Official Standard NOM-068-FITO-2000, published on 21 April 2000, will therefore cease to have effect.

The title of Mexican Official Standard NOM-068-FITO-2000: "Establishing phytosanitary measures to combat and prevent the spread of Moko disease in bananas" has been amended to read as follows: Mexican Official Standard NOM-068-SAG/FITO-2015: "Establishing phytosanitary measures to combat and prevent the spread of Moko disease in bananas". The scope, content and objective of the Mexican Official Standard remain unchanged.
