Please be advised that, following the closure of the related consultation period and pursuant to the "Agreement establishing the module for phytosanitary requirements governing the importation of goods regulated by the Ministry of Agriculture, Livestock, Rural Development, Fisheries and Food in relation to plant health", published in the Mexican Official Journal on 7 February 2012, the phytosanitary requirements governing the importation of botanical cucumber (*Cucumis sativus* L.) seeds originating in and coming from Latvia entered into force on 16 May 2016.
