Addendum

The following communication, received on 9 January 2013, is being circulated at the request of the delegation of Mexico.

Notice of cancellation of Mexican Official Standard NOM-008-FITO-1995 establishing the phytosanitary requirements and specifications for the import of fresh fruit and vegetables

On 21 December 2012, the Ministry of Agriculture, Livestock, Rural Development, Fisheries and Food published in the Official Journal (*Diario Oficial de la Federación*) the notice of cancellation of Mexican Official Standard NOM-008-FITO-1995 establishing the phytosanitary requirements and specifications for the import of fresh fruit and vegetables, published on 8 July 1996 in the Official Journal. The amendments to this Standard, published in the Official Journal on 17 April 2002, 16 May 2002, 18 April 2006, 6 July 2006, 6 February 2008 and 22 May 2009, have also been cancelled.

The phytosanitary requirements and specifications for the import of the goods regulated by the above-mentioned Mexican Official Standard have been incorporated into the Phytosanitary Import Requirements Module (*Módulo de Requisitos Fitosanitarios para la Importación*). Interested parties may therefore consult the phytosanitary import requirements in that Module.

- Withdrawal of proposed regulation
