The following communication, received on 14 August 2018, is being circulated at the request of the delegation of Nicaragua.

Nicaraguan Mandatory Technical Standard (NTON) No. 03 094-18/Central American Technical Regulation (RTCA) No. 67.04.54:18 Foods and beverages. Food additives

On 4 February 2011, the Republic of Nicaragua notified draft Nicaraguan Mandatory Technical Standard (NTON) No.03 094 - 10/Central American Technical Regulation (RTCA) No. 67.04.54:10 Foods and beverages. Food additives, in document G/SPS/N/NIC/57 and the Addendum thereto on 4 May 2011, with the aim of establishing the food additives for food that is marketed in the territory of the States Parties, excluding processing aids or substances normally used as ingredients.

This addendum concerns a:

- Notification of adoption, publication, or entry into force of regulation
- Modification of content and/or scope of previously notified draft regulation
- Withdrawal of proposed regulation
