6.	Description of content: This letter introduces a temporary restriction due to the outbreak of the African swine fever virus (ASF) in February 2014 on the territory of Poland. This measure applies on import of: <ul style="list-style-type: none">• live pigs and its genetic material;• pork products (which were not heat treated no less than 80°C for at least 30 minutes);• products from slaughter of wild boars;• horn-hoofed and leather, intestinal materials;• bristles;• feed for pigs;• hunting trophies, which were not subjected to full taxidermy treatment;• previously used equipment for maintenance, transportation, slaughter and cutting of pigs.
