No. 48, Vol. 29 dated 1 December 2016, which indicates that a HPAI outbreak has reoccurred in Tunisia, it is deemed necessary for the Kingdom of Saudi Arabia to prevent the entry of HPAI disease into the country. Therefore, the import of live birds, hatching eggs and one-day old chicks from Tunisia to the Kingdom of Saudi Arabia is temporarily suspended. |
