Description of content: Amendment of pesticide MRLs for Bicyclopyrone, Cartap, Chlorfluazuron, Chlorpyrifos, Clothianidin, Cyantraniliprole, Cyazofamid, Cyenopyrafen, Cyflufenamid, Ethiprole, Etofenprox, Fonicamid, Flupyrauxifen-benzyl, Fluazinam, Flupyradifurone, Flutriafol, Fosetyl-aluminium, Fosthiazate, Hexaconazole, Imidacloprid, Isofetamid, Isotianil, Kresoxim-methyl, Lufenuron, Metaldehyde, Methoxyfenozide, Milbemectin, Oxolinic acid, Pencycuron, Penthiopyrad, Pydiflumetofen, Pyflubumide, Pyribencarb, Quinoxifen, Sedaxane, Sethoxydim, Spinetoram, Spinosad, Sulfoxaflor, Tebuconazole, Tetraconazole, Tolclofos-methyl and Trifloxystrobin in cereal grains, sugarcane, coffee beans, dried beans, tree nuts, fruits and vegetables.
