The following communication, received on 31 July 2015, is being circulated at the request of the Delegation of the <u>United States of America</u>.

Thiabendazole; Pesticide Tolerances for Emergency Exemptions

This regulation establishes a time-limited tolerance for residues of thiabendazole in or on succulent shelled peas. This action is associated with the utilization of a crisis exemption under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) authorizing use of the pesticide as a seed treatment on succulent pea seeds. This regulation establishes a maximum permissible level for residues of thiabendazole in or on this commodity. The time-limited tolerance expires on 31 December 2018.

This regulation is effective 17 July 2015. Objections and requests for hearings must be received on or before 15 September 2015, and may be identified by docket identification (ID) number EPA-HQ-OPP-2015-0396.
