Flutriafol; Pesticide Tolerances

This regulation establishes, amends, and removes tolerances for residues of flutriafol in or on multiple commodities.

This action is subsequent to a notice published in the Federal Register of 17 December 2014, in which the Agency announcing the filing of a petition for residues of the fungicide, in or on Brassica, head and stem, subgroup 5A at 1.5 ppm; Brassica, leafy greens, subgroup 5B at 7.0 ppm; egg at 0.01 ppm; hog, liver at 0.05 ppm; hog, meat by-products, except liver at 0.02 ppm; hog, muscle at 0.01 ppm; leaf petioles, subgroup 4B at 3.0 ppm; leafy greens, subgroup 4A, except head lettuce at 10 ppm; lettuce, head at 1.5 ppm; poultry, meat by-products at 0.02 ppm; radicchio at 1.5 ppm; sorghum, grain, forage at 2.0 ppm; sorghum, grain, grain at 1.5 ppm; and sorghum, grain, stover at 6.0 ppm.
