Novaluron; Pesticide Tolerances

This regulation establishes tolerances for residues of novaluron in or on multiple commodities and removes several existing tolerances which are identified and discussed later in this document. This regulation additionally revises existing tolerances in or on vegetable, cucurbit, group 9; and plum, prune, dried.

This regulation is effective 22 July 2015. Objections and requests for hearings must be received on or before 21 September 2015, and may be identified by docket identification (ID) number EPA-HQ-OPP-2014-0232.
